Scratches or other injury from stalls or enclosures, grooming tools, or other equine equipment and tack. Allergic reactions to animals, hay, or other allergens. Tripping in holes or on materials or equipment. Slipping, falling, or otherwise being injured in the barn, in stalls, or on the grounds, which can be slippery, muddy, wet, or contain or present other hazards.
	cknowledge that horseback riding is a dangerous activity and involves risks that may cause serious injury and in some cases death, because the unpredictable nature and irrational behavior of horses, regardless of their training and past performance.
1	oluntarily assume the risk and danger of injury or death inherent in the use of any horse equipment and/or gear provided to me by Stable.
	ereby acknowledge that although there may be supervision during my time spent at Stable, there will not be a nurse on the premises and able, its principals and agents, bear no responsibility for my health or medical care.
	epresent that, to the best of my knowledge, I do not have a health condition that would make it inadvisable for me to participate in Stable uine activities, and that I am not under the influence of alcohol or drugs which is prohibited.
I	ertify that I have sufficient health, accident and liability insurance to cover my bodily injury or property damage that may incur while rticipating in horse activities. If I have no such insurance, I certify that I am personally responsible for all such expenses or liability and hole harmless.
	gree to abide by and follow any instructions given or rules established by Stable, its principals or agents.
(gree to indemnify, save and hold harmless Stable and its principals and agents from and against any loss, liability, damage, attorneys' fees, costs that they may incur arising out of or in any way connected with either my presence or participation at Stable or any acts or omissions Stable principals or agents.
	expressly agree that the foregoing release and waiver of liability, assumption of risk, and indemnity agreement is governed by the State of exconsin and is intended to be as broad and inclusive as permitted by Wisconsin law, and that in the event any portion of this Agreement is termined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the Agreement shall not be affected impaired in any way and shall continue in full legal force and effect.
	cknowledge that this document is a contract and agree that if a lawsuit is filed against Stable, its principals or agents, for any injury or mage in breach of this contract, I will be responsible for any attorneys' fees and costs incurred by Stable in defending such an action.
