2023 Breeding Fees & Summary Information

Breeding Season: February 1, 2023 to July 1, 2023 *(Later dates by appointment)*

Stallion Breeding Fee: \$1,000 *(All breeding fees must be paid in full before first collection/shipment)*

Discounts: *(Discounts may not be doubled up or used in conjunction with other discounts)*

Early Bird Discount ~ Mare owners who sign a contract and pay the 2023 Stallion Breeding Fee in full by December 1, 2022 shall receive a \$400 discount on the current Stallion Breeding Fee. *Total Stallion Breeding Fee Due = \$600*

Loyal Breeder Discount ~ Mares that have previously produced a foal sired by Impulsified shall receive a \$500 discount on the current Stallion Breeding Fee. *Total Stallion Breeding Fee Due = \$500*

Multiple Mare Discount ~ Mare owners choosing to breed more than one mare to Impulsified during the same breeding season shall receive a multiple mare discount on the current Stallion Breeding Fee according to the following schedule: *(All mares must be registered/leased under the same owner as shown on registration certificates to qualify; please complete a separate contract for each mare)*

❖ 2 Mares ~ \$100 Off Each Mare. *Total Stallion Breeding Fee Due = \$900 per mare*

❖ 3+ Mares ~ \$200 Off Each Mare. *Total Stallion Breeding Fee Due = \$800 per mare*

Proven Mare Discount ~ Mare owners choosing to breed their proven mare to Impulsified shall receive a proven mare discount on the current Breeding Fee according to the following schedule: *(Must provide proof of APHA/AQHA/PtHA award to qualify)*

❖ ROM Earner or Producer ~ \$100 Off. *Total Stallion Breeding Fee Due = \$900*

❖ Honor Roll/SUP Earner or Producer ~ \$200 Off. *Total Stallion Breeding Fee Due = \$800*

❖ World/Congress/Reserve Champion Earner or Producer ~ \$300 Off. *Total Stallion Breeding Fee Due = \$700*

❖ Champion/Versatility/Superior All-Around/Supreme Champion Earner or Producer ~ \$400 Off. *Total Stallion Breeding Fee Due = \$600*

Collections/Shipping: *(Fees Are Paid Directly to the Veterinary Clinic used for Collection/Shipping)*

A minimum of 24 hours' notice prior to the Collection/Shipping date is required to make arrangements!

A Semen Request Form must be on file, complete with credit card information, before collection.

Collection/Shipping days are Mondays, Wednesdays, and Fridays. Not all locations have Saturday delivery via Fed-Ex/UPS, an alternate delivery address or a CTC shipment may be required – if this applies, the additional address or airport preference must be included on the Semen Request Form.

Standard disposable containers will be used unless the use of an Equitainer is specified on the Breeding Contract.

Topline Equine Veterinary Care (TEVC): *(Fees listed are subject to change at any time at the discretion of the clinic)*

❖ Collection & Shipping Charge via Fed-Ex/UPS on TEVC's account for Monday-Friday Delivery ~ \$370

❖ Collection & Shipping Charge via Fed-Ex/UPS on TEVC's account for Saturday Delivery ~ 400

❖ Counter to Counter (CTC) Collection & Shipping Charge via Air Net ~ \$480+

❖ Collection Charge for Mare Owner pickup at TEVC or using Mare Owner's Fed-Ex/UPS account ~ \$275

Mare Reproductive Tests:

Open/barren mares must have a Negative uterine culture and equine cytology with sensitivity, current within 30 days, prior to first semen shipment. If mare does not have these tests prior to semen requirement and a shipment is made, a second shipment may not be made until lab results are received by Stallion Owner. For maiden mares, in absence of these reproductive tests, a third shipment may be refused by Stallion Owner until satisfactory lab results are received.

Payment Options: *(All fees include any applicable Wisconsin sales tax)*

Payments to Stephanie Plote Performance Horses are accepted in the form of cash, check, PayPal, Venmo, or Zelle.

A 5% Bank Fee will apply to payments "invoiced" or paid as "Goods & Services" and a \$50 Bank Fee will apply to returned checks.

Payments to TEVC are accepted in the form of cash, check or credit card.

A credit card must be on file with clinic regardless of payment method used for actual collection/shipment costs.
